

## ***What is JCEIP?***

The Juvenile Court Early Intervention Program (JCEIP) helps system involved individuals address substance use disorders.

Clients referred to JCEIP for an assessment will meet with a clinician to determine if a substance use disorder exists and receive referrals to community treatment providers to address any behavioral health and systemic needs. Assessments are available for system involved clients of all ages, for no charge. Insurance is not required for an assessment

JCEIP also offers support and educational groups for system involved youth.

Referrals are requested for all services.

### ***Drug testing/urinalysis***

All assessments include a urinalysis with laboratory confirmation.

### ***Groups***

#### ***Substance Use Disorder Support Group (bi-weekly)***

A harm reduction focused group for adolescent active users or those new to Recovery to provide peer support

### ***Referrals***

Anyone can submit a referral to JCEIP! This includes the court, DJS CMS (intake and probation), DSS case managers, mentors, family members, social workers, and attorneys.

Clients can also refer themselves!

JCEIP offers appointments and walk-in hours for assessments. We can provide proof of appointment for school/work.

Clients should allow 45-60 minutes for assessments.

Referrals are required for assessments and groups.
